## Party Package Agreement

For your safety and enjoyment, please read carefully the following policies and rules. Assumption of Risks: Participation in activities at Campus Recreation pools carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from minor injuries such as scratches, bruises, and sprains to major injuries such as eye injury or loss of sight, joint or back sprains, strains, breaks, concussions, cuts, cardiac arrest, partial or total paralysis, drowning and death. We strongly recommended that you consult your personal physician before starting any strenuous activity.

*Supervision Requirements*: We require at least 1 responsible adult per 5 children under the age of 7 and 1 responsible adult per 8 children under the age of 10. Children 11 and over require a 15 to one ratio. A maximum of **15 swimmers** can be accommodated for the party. Non-swimmers and individuals on deck will not count toward the 15 swimmer maximum.

Parents/guardians may be required to be in the water and within arm's reach of children if the lifeguard staff determines there is a need to provide additional safety measures due to swimming capabilities of party participants. Individuals who are unable to swim and those who need flotation devices must always have an adult <u>in the water and always within arm's reach</u>.

To enhance the safety of all participants, there may be other supervision requirements that will be reviewed on the day of the rental. Unless otherwise stipulated, pool parties include the pool and deck area, (and spa if over the **age of 16**), the "wet" meeting room near the pool entrance and both the main locker rooms and the family changing room. Use of other activity areas is prohibited.

General Aquatic Center Rules: As you arrive for your event, please take the time to carefully read and follow all facility rules posted at the pool. Listed below are a few rules that are of particular importance:The CRCE pool is all shallow water and therefore diving is prohibited

• No running on the deck or rowdy behavior in the pool facility

• Please be advised that the waterslide is an adventure activity and may expose the rider to possible physical injury. In deciding to participate the rider assumes full responsibility of any injury sustained.

• To use the waterslide you must be at least 36 inches tall and be able to complete a swim test administered by aquatics staff. Swim test will include swimming 20 yards and then demonstrate self-sufficient swimming capabilities in our catch pool area with a current. • Parents or guardians are not allowed to ride down with smaller participants on the slide; each participant must ride separately on the slide.

• Individuals are not allowed to wear floatation devices to ride the slide, they must be able to exit the slide flume and swim to the exit by themselves (Parents/Guardians will not be allowed to catch children at the bottom of the slide).

• No flotation devices are allowed besides those approved by the U.S. Coast Guard. (i.e. no water wings, inner tubes, inflatable rafts, inflatable animals or objects, etc.) Campus Recreation will provide any necessary personal flotation devices (i.e. life jackets) for any novice or non-swimmer.

## **Other General Information**:

• All guests will be required to sign-in at Member Services upon arrival.

• Outside food and drink are allowed in the meeting room area only. At no time can any glass materials enter the pool deck. If you are transporting any glassware, crock pots, etc. you must do so through the locker room spaces.

- Campus Recreation has a zero tolerance policy in regards to alcoholic beverages being
  possessed or consumed within the facility. If caught breaching this policy, staff will seize party
  operations and all personnel involved with the party will be asked to leave the facility. No refund
  will be issued.
- Campus Recreation offers limited refrigeration and ice upon request.
- Please do not tape party decorations to the walls or glass. Special poster putty may be used.

## Payment:

• Cost per party is **\$165 (Member)** or **\$195 (non member)** for up to 15 participants. There is a maximum of 15 swimming participants per party.

• Payment must be made in *full* to reserve the space. Cancellations must be made at least 14 days prior to the start time of the party in order to receive a full refund of the party package. Any cancellations made inside of 14 days from the start time of the party will receive a 50% refund. All refunds are subject to a \$5 processing fee. To reschedule a party, you will simply need to rebook after the refund request is approved. All rescheduled events must take place at least 14 days after the rebooking.

• No flotation devices are allowed besides those approved by the U.S. Coast Guard. (i.e. no water wings, inner tubes, inflatable rafts, inflatable animals or objects, etc.) Campus Recreation will provide any necessary personal flotation devices (i.e. life jackets) for any swimmer uncapable
